Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ('the Listing Regulations') this is to inform that the Office of the Additional Commissioner, CGST & Central Excise, Kolkata South Commissionerate, Kolkata, has issued an Show Cause Notice u/s 74 of CGST Act, 2017 vide ref. no. ZD190425029134I dated 16<sup>th</sup> April 2025 and levied a penalty of Rs. 20,42,34,468.00/- (as per the table below) against difference in unbilled revenue pertaining to FY 2017-18 and 2018-19.
